SUPPLEMENTARY REGULATIONS:

1. JURISDICTION: An event for solo motorcycles, held under the National Sporting Code of the Auto Cycle Union, Standing Regulations, these Supplementary Regulations and any Final Instructions that may be issued.
2. ELIGIBILITY: Open to members of SCEC driving solo (Enduro, Moto-X or Trail type) motorcycles. Working lights are not required. ACU licence required (see below). Minimum age 16 years.
3. VENUE: The Inside Park, near Blandford, Dorset.
4. COURSE: A superb flowing circuit of around 5 miles following the flowing tracks and trails around the Inside Park. The event is held entirely on private land and is suitable and enjoyable for riders of all abilities.
5. SCRUTINEERING: 9:15 to 10:15 hrs. In addition to their Machine, competitors must produce Helmet and a suitable Fire Extinguisher for refuelling.
6. TYRES: Rear: Enduro (eg: 13mm max tread height) Front: Free choice.
7. NOISE LEVEL: Standard Enduro limit
8. ENTRIES: Closed when full & accepted strictly in order of receipt. Postal entries must be made on official form & sent to the Secretary of the Meeting with correct entry fee & three first class stamps. Payment by cheque or postal order only payable to SOUTHERN COUNTIES ENDURO CLUB.
9. ENTRY FEES: Entries received and paid prior to race day £35.00 (ACU licence holders) or £43.00 with ACU day licence. Surcharge for entries received and/or paid for on race day £10.00 Cheques will not be cashed prior to 2 weeks before event.
10. INSURANCE: There is no longer personal accident cover for competitors included & we strongly advise you take out sufficient cover for your needs. The ACU brokers (Loctons Tel: 0161 242 5159) can provide additional cover on request.
11. NON STARTERS & ABANDONMENT: Anyone who enters this event must give at least 7 days notice in writing of non attendance to be considered for a refund. An administration charge of £10:00 will be deducted from refunds. The organisers reserve the right to postpone, alter or cancel events. In the event of unavoidable cancellation prior to the event date the organisers will retain £10.00 to cover administration and other cancellation costs. In the extremely unlikely event of forced cancellation on the day of the event the organisers may retain as much as required to cover the event costs.

Liability cover in respect of any claim is limited to £10million and £5million for Medical Malpractice ● I enclose my entry fee of £35:00 (plus £8:00 for ACU day licence if required)

Acknowledgement of the risks of motorsport: I understand that by taking part I am exposed to the risk of death, becoming permanently disabled or suffering some other serious injury and acknowledge that even in the event that negligence on the part of the ACU, the promoter, the organising club, the venue owner, or any individual carrying out duties on their behalf were to be a contributory cause of any serious injury I may suffer, the dominant cause of any serious injury will always be my voluntary decision to take part in a high risk activity.
