### SUPPLEMENTARY REGULATIONS:

- JURISDICTION: Held under the National Sporting Code & Cross-Country/Enduro regulations of the SCEC, the AMCA, these regs & any Final Instructions that may be issued.
- ELIGIBILITY: Open to registered riders and invited guests of the SCEC driving solo (Enduro, Moto-X or Trail type) motorcycles. Working lights are not required. Annual AMCA enduro registration (£15) is required – if you are not registered you will be given an registration form when you sign on which should be completed and sent to the AMCA as soon as possible after the event.
- VENUE: Somerley Park, near Ringwood, Hampshire.
- COURSE: A superb cross-country circuit of around 7 miles. Held entirely on private land & suitable for enthusiastic riders of all abilities.
- TECHNICAL INSPECTION & SIGNING ON: From 9:00 to 10:00 hrs. Sign-on before tech inspection. Noise limit standard enduro limit. Rear tyres Trials or Enduro pattern only.
- SIGHTING LAP: The course will be open for inspection on foot prior to the event.
- ENTRIES: In order to ensure maximum enjoyment entry numbers will be restricted & accepted strictly in order of receipt. Registered riders get priority for places. Entry will be opened to non-registered riders 2 weeks before event. All entries must be made on official form & sent to the Secretary of the Meeting with correct entry fee & three first class stamps or made via the on-line entry system at enduro.org.uk. Cheques/Postal Orders should made payable to SOUTHERN COUNTIES ENDURO CLUB.
- ENTRIES FEES: Postal entries received prior to race day £38.00 (SCEC club members) £45.00 (non members) Entries on day (if available) £45.00. AMCA insurance is included in all cases. Cheques will not be cashed prior to 2 weeks before event. On-line entries also available - see www.enduro.org.uk for details.
- NON STARTERS & ABANDONMENT: Entry fees will only be refunded up to 7 days before the event & will be subject to £10.00 cancellation fee. The organisers reserve the right to postpone, alter or cancel events. In the event of unavoidable cancellation prior to the event date the organisers will retain £10.00 to cover administration and other cancellation costs. In the extremely unlikely event of forced cancellation on the day of the event the organisers may retain as much as required to cover the event costs.
