SUPPLEMENTARY REGULATIONS:

1. JURISDICTION: An event for solo motorcycles, held under the National Sporting Code of the Auto Cycle Union, the ACU Standing Hare & Hounds/Cross Country Regulations, these Supplementary Regulations and any Final Instructions that may be issued.
2. OFFICIALS: Clerk of the Course:- Gary Warr (ACU 13867) Tel: 01929 448244. Secretary of the Meeting:- Josie Warr Tel: 01929 463265
3. ELIGIBILITY: Open to members of SCEC and invited guests driving solo (Enduro, Moto-X or Trail type) motorcycles. Working lights are not required. ACU licence required (see below). Minimum age 16 years.
4. VENUE: Pallington Forest, near Dorchester, Dorset.
5. COURSE: A superb traditional 'forest enduro' type circuit of around 5 miles. Held entirely on private land & suitable for enthusiastic riders of all abilities.
6. MACHINE EXAMINATION: 9:00 to 10:00 hrs. In addition to their Machine competitors must produce Helmet & suitable Fire Extinguisher for refuelling.
7. TYRES: Rear: Trials Pattern (19" may use Speedway pattern) Front: Free choice.
8. NOISE LEVEL: Standard Enduro limit
9. ENTRIES: Closed when full & accepted strictly in order of receipt. Postal entries must be made on official form & sent to the Secretary of the Meeting with correct entry fee & three first class stamps. Payment by cheque or postal order only payable to SOUTHERN COUNTIES ENDURO CLUB.
10. ENTRY FEES: Postal entries received and paid prior to race day £38.00 (club members) or £48.00 (non-members). ACU day licence if required (£10.00) Entries paid for on day - as above plus £10.00 Cheques will not be cashed prior to 2 weeks before event.
11. **INSURANCE: There is no longer personal accident cover for competitors included & we strongly advise you take out sufficient cover for your needs. The ACU brokers (Loctons Tel: 0161 242 5159) can provide additional cover on request.**
12. NON STARTERS & ABANDONMENT: Anyone who enters this event must give at least 7 days notice in writing of non attendance to be considered for a refund. An administration charge of £10:00 will be deducted from refunds. The organisers reserve the right to postpone, alter or cancel events. In the event of unavoidable cancellation prior to the event date the organisers will retain £10.00 to cover administration and other cancellation costs. In the extremely unlikely event of forced cancellation on the day of the event the organisers may retain as much as required to cover the event costs.
