### SUPPLEMENTARY REGULATIONS:

1. JURISDICTION: An event for solo motorcycles, held under the National Sporting Code of the Auto Cycle Union, the ACU Standing Hare & Hounds/Cross Country Regulations, these Supplementary Regulations and any Final Instructions that may be issued.
2. OFFICIALS: Clerk of the Course:- Gary Warr (ACU 13867) Tel: 01929 448244. Secretary of the Meeting:- Josie Warr Tel: 01929 463265
3. INSURANCE: There is no longer personal accident cover for competitors included & we strongly advise you take out sufficient cover for your needs. The ACU brokers (Loctons Tel: 0161 242 5159) can provide additional cover on request.
4. ELIGIBILITY: Open to members of SCEC driving solo (Enduro, Moto-X or Trail type) motorcycles (day membership available). ACU licence required (see below). Minimum age 15 yrs.
5. VENUE: Pallington Forest near Briantspuddle, Dorset.
6. COURSE: A traditional forest circuit featuring 5 to 6 miles of forest tracks, paths and trails around Pallington Forest. The event is held entirely on private land and is suitable and enjoyable for riders of all abilities.
7. MACHINE EXAMINATION: 9:00 to 10:00 hrs. In addition to their Machine competitors must produce Helmet. If you wish to refuel during the event you will need a suitable Fire Extinguisher.
8. TYRES: Rear: Enduro specification (13mm max tread depth) - Front: Free choice.
9. NOISE LEVEL: Standard FIM Enduro limit
10. ENTRIES: Closed when full & accepted strictly in order of receipt. Postal entries must be made on official form & sent to the Secretary of the Meeting with correct entry fee. Payment by cheque or postal order only payable to SOUTHERN COUNTIES ENDURO CLUB.
11. ENTRY FEES: Postal entries received and paid for before closing date £40.00 (club members) or £50.00 (non-members). ACU day licence if required (£10.00). Late entries (if available) - as above plus £10.00 Cheques will not be cashed prior to 2 weeks before event.
12. NON STARTERS & ABANDONMENT: Anyone who enters this event must give at least 7 days notice in writing of non attendance to be considered for a refund. An administration charge of £10:00 will be deducted from refunds. The organisers reserve the right to postpone, alter or cancel events. In the event of unavoidable cancellation between close of entries and the event date the organisers may retain £10.00 to cover administration and other cancellation costs. In the extremely unlikely event of forced cancellation on the day of the event the organisers may retain as much as required to cover the event costs.

**Entry declaration:** I / we the undersigned apply to enter the event described above and in consideration thereof:-

- ⋆ I / we hereby declare that I / we have had the opportunity to read, and that I / we understand the National Sporting Code of the ACU, the ACU Standing Regulations, such Supplementary Regulations as have or may be issued for the event, and agree to be bound by them.
- ⋆ I / we further declare that I am / we are physically and mentally fit to take part in the event and I am / we are competent to do so.
- ⋆ I / we confirm that I / we understand the nature and type of event we are entering and its inherent risks and agree to accept the same notwithstanding that such risks may involve negligence on the part of the organisers or officials.
- ⋆ I / we confirm that the machine(s) as described below which I / we compete on shall be suitable and proper for the purpose.

- ⋆ I / we agree that I am / we are required to register our arrival by "signing on" at the designated place not less than 30 minutes prior to commencement of my/our practice or first competition, whichever occurs first.
- ⋆ I/we confirm that I/we are not suspended or my/our ACU Licence has not been suspended/withdrawn from any ACU competition.

⋆ **I/we understand and accept that as the Supplementary Regulations state the Insurance cover for this event is "Basic" there is no Personal Accident cover for Competitors and Liability cover in respect of any claim made by third parties is limited to £10 million and £5 million for Medical Mal-practice.**
